Scholarship Qualifications

1. Applicant **must** be an NAE Federal Credit Union member **before** submitting their completed application.
2. Applicant must be a 2021 graduating senior entering an accredited college, university as a full-time student in a degree program leading to an associate's or a baccalaureate degree.
3. Applicant must have a minimum GPA of 2.75 to qualify.
4. A student who accepts an appointment to a U.S. Military Service Academy, any 4-year ROTC scholarship or any other scholarship, grant, or fellowship covering full tuition, books and fees is not eligible to receive this scholarship.
5. This award will be paid directly to the school you choose to attend.
6. Incomplete applications will not be considered.

Application Requirements

1. ____ A completed 2020-2021 scholarship application.
2. ____ Official high school transcripts (sealed document preferred).
3. ____ Photocopy of report card for the first semester of the 2019-2020 academic year.
4. ____ Copies of student's best SAT and/or ACT test scores.
5. ____ Two Letters of Recommendation for current school year. One letter may be from a teacher or counselor. The other letter can be from a neighbor, community or religious leader, or someone who knows you well. Letters from relatives will not be accepted.
6. ____ A typed essay of no more than 500 words that express how personal financial responsibility is important to achieving your goals.

Selection Criteria

1. Character and Leadership (e.g., extra-curricular involvement, honors, awards, achievements, volunteering and employment).
2. Scholastic Improvement (e.g., AP/Honors classes, GPA, awards, SAT and ACT scores).
3. Financial need
4. Essay response. (Communication skills, insight, ambitions)
